

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.drcenoscapescapes.com and DRC Landscaping LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to DRC Landscaping LLC include www.drcenoscapescapes.com and DRC. The DRC website is a informational site. By using the DRC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, DRC may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through DRC's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. Use of your Personal Information

Sharing Information with Third Parties

DRC does not sell, rent or lease its customer lists to third parties.

DRC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to DRC, and they are required to maintain the confidentiality of your information.

DRC may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on DRC or the site; (b) protect and defend the rights or property of DRC; and/or (c) act under exigent circumstances to protect the personal safety of users of DRC, or the public.

Tracking User Behavior

DRC may keep track of the websites and pages our users visit within DRC, in order to determine what DRC services are the most popular. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by DRC. Use of Cookies
